**Agility Fun Ring:** All cats are invited to participate in the agility fun ring. The five fastest competitors will be recognized.

**Show Hall:** Our show hall is the Holshausen Building at the North Carolina State Fairgrounds. The address is: 1025 Blue Ridge Road, Raleigh, NC 27607. The show hall is heated. Parking is free.

Alcoholic beverages are not allowed on the Fairgrounds property. A concession service will be available during show hours. There is no smoking in the showhall.

**Hotel Information:** Quality Inn & Suites, RDU Airport - 1001 Aerial Center Pkwy, Morrisville, NC 27560. Call hotel directly at (919) 481-3600 and request booking in the "CAT SHOW" group. Room rate is \$59 for all room types. There is a \$15 one-time-per-stay/non-refundable pet deposit. Hotel provides a free hot breakfast. The hotel also provides free transportation to/from the airport. Transportation is not available to/from the showhall. The club will be enforcing the TICA Hotel Policy. **Accessibility:** The Holshausen Building and Quality Inn meet ADA accessibility guidelines for ramps and wheelchair accessible facilities.

**Airport Information:** Raleigh - Durham International Airport (RDU) is about 11 miles/15 minutes from the show hall.

**Entry & Payment Information:** All online entries must be paid prior to the expiration of those fees otherwise you will be responsible for the fees at time of payment. Make checks payable to **Vision Cat Club**. PayPal payments can be sent to [visioncatclub@nc.rr.com](mailto:visioncatclub@nc.rr.com). All payments at check-in must be EXACT CASH only. No substitutions after closing. No refunds for failure to bench. Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE CLOSING.

**Check in & Show Hours:** Check-in will be 7:00 a.m. - 8:00 a.m. Judging will start promptly at 8:00 a.m. Advertised show hours are until 5:00 p.m. In consideration of our paying spectators, no cats may be removed from the show hall before the end of advertised show hours without show manager's permission.

**Benching and Supplies:** A single cage (22x22x22) is provided for each cat entered. Two (2) kittens or one (1) cat are permitted in a single cage. Double cages (22x22x45) are available upon request for an additional fee of \$20. Since single width "wire" cages are unavailable, if you are bringing your own cage, even if only a single width cage, you must purchase a double cage space. A grooming space is the same size as a double cage space. Special benching requests will be honored to the best of our ability. For your cat's comfort, the top, sides, and bottom of the cages must be covered. Vending from the benching area, unless prearranged with the club, is prohibited. Litter will be provided, but please bring your own litter box.

**Registration:** With the exception of cats competing in the Preliminary New Breeds, Advanced New Breeds, and New Traits classes, registration with TICA is not necessary to compete in the cat's first show, but is required for confirmation of titles and scoring for TICA Regional and International Awards after the cat's first TICA show.

**Household Pets:** HPPs 8 months of age and older must be spayed or neutered. If you are unsure of your cat's color, please send a color photo of your cat, along with your entry. Your photo will be returned at check-in.

**Kittens:** Kittens entered in the show must be at least 4 months, but less than 8 months of age on the day of the show. Altered kittens are eligible for entry.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. Any cat or kitten from a house or cattery where there has been fungus or any infectious or contagious illness within 21 days prior to the opening date of the show is ineligible for entry and/or exhibition. Any cat which is obviously pregnant or lactating will be disqualified. All claws (front and back) must be clipped prior to judging. Declawed cats are eligible for competition, although this practice is not sanctioned. This is a non-vetted show.

**Cats for Sale:** Kittens must be three (3) calendar months of age. Proof of age must be provided on request. No kittens or cats may be confined to carriers during show hours. Any person disregarding these rules will be asked to leave the showhall. Sales cages will only be available for individuals with entries in the show.

**Show Rules:** TICA Show Rules will be strictly enforced. By entering all exhibitors agree to abide by the decisions of the Judges and Show Committee. **Liability:** No watchman will be provided during non-show hours. Cats cannot be left in the show hall overnight. Vision Cat Club will take reasonable care to safeguard the personal property of exhibitors; however, neither the club, its members nor the NC State Fairgrounds or Quality Inn will be liable for any loss, damage or injury to exhibitors or to their cats.

**This show is being held in-conjunction with Midlantic Persian and Himalayan Fanciers CFA-licensed show being held on Saturday March 30, 2019. Not TICA registered? No problem.
