Show Hall: Villas by the Sea Conference Center, 1175 N. Beachview Drive, Jekyll Island, GA 31527, (912) 635-2521. This is a climate-controlled facility and is completely ADA compliant. Outside food is allowed. Food will be available for purchase. There is a \$10 parking/entry fee which must be paid when entering the island. This is an “all-in-one” show hall/show hotel!!

Show Hotel: Villas by the Sea Resort & Conference Center, 1175 North Beachview Dr., Jekyll Island, GA 31527 (912-635-2521). These are all condo type accommodations; most include full kitchens. Many are two stories, with sleeping areas upstairs; if you have a problem with stairs, please verify that your unit is all on one level when making your reservation. As handicap accessible units are limited, please be considerate and reserve these only if you require a wheelchair. Mini Villa/Studio (Islandside)-\$139, Studio (ground floor)-\$139, One Bedroom Villa-\$149, (Islandside), \$159 (Oceanside), \$169 (Oceanview), Two Bedroom Villa-(Islandside)-\$189, (Oceanside)-\$199, (Oceanview)-\$209. Three Bedroom Villa-(Islandside)-\$219, (Oceanside)-\$229, (Oceanview)-\$239. 7% Sales Tax, 7% Hotel Occupancy Tax, 3% Destination Fee, \$5 per night State Fee and \$26.75 Resort Fee are additional to room rate. A Deposit of first night room rate+tax is due upon booking. Reservations cancelled less than 3 days prior to arrival will forfeit deposit. There is a non-refundable PET FEE of \$75 per room per 2 cats. Additional fees will apply if extensive cleaning is required. Please mention **Group Number 567458** when calling 1-912-635-2521 to make reservations. Hotel check-in is at 4 pm, and check-out is no later than 11 am. Reservations must be made by **October 9, 2026**. Rooms not picked up or without a deposit will be released and sold on a SPACE AVAILABLE basis. Rooms cancelled with less than 3 days' notice will forfeit deposit.

Group rates are available 3 days prior and 3 days after our show if you want to have an extended vacation.

Please make every effort to leave your room in the condition it was found, in not better. Be sure to confine spraying males (and females!) and clean up after yourself and your cats. TICA Hotel Guidelines will be enforced.

Show catalogs: Each exhibitor will be provided with an electronic catalog that will be sent to the email address in TOES used to enter the show. The electronic catalog will be emailed 2 days before the show. If you want a printed catalog, printed catalogs are available for an additional charge and must be requested prior to closing.

Transportation: Most major carriers fly into Jacksonville International Airport (JAX), which is an approximately 1 hour drive from the show hall/hotel. Limited air service (DELTA only) is available at Glynco Jetport (BQK) in Brunswick, which is approximately 25 minutes away. Another alternate airport is Savannah International (SAV) which is approximately 1 hour, 10 minutes away. Taxis and rental cars are available at all airports. The causeway to Jekyll Island is easily accessed from I-95 and US 17.

Show Hours: Check-in will be from 1:00-2:00 p.m. on Friday and from 7:30-8:30 a.m on Saturday. Judging on Friday will begin promptly at 2:30 p.m. The Saturday AM session will begin promptly at 8:30 a.m. Judging will begin promptly at 1:30 for the PM session. Check-in on Sunday will be from 8-9 a.m. with judging beginning promptly at 9 a.m. Advertised show hours on Saturday will be from 9 am-5 pm and on Sunday from 9 am – 1:30 pm. The show is closed to the public on Friday, and you may leave when judging for your class has concluded for the evening. All cats must remain in the show hall during advertised show hours to the public unless permission to leave is given by show management. No cats may be left overnight in the show hall.

Pajama Party: On Friday we will have a “pajama party”. The show will be closed to the public so feel free to come and show in comfortable, family-friendly pajamas and your favorite slippers. This is a great way to relax into the weekend.

Registration: To show a cat in a TICA, your cat must be able to be registered in TICA. If not already TICA registered, pedigree cats must provide proof of registerability to enter. This can include registration paperwork from another recognized registry, pedigree, or similar information. No cats of breeds not recognized by TICA for registration may be advertised as those breeds in the showhall. Contact the entry clerk for more information and assistance. Cats competing in the household pet and household pet kitten classes do not need to be registered or provide proof that they can be registered. However, to be scored for TICA titles and Regional/International awards, all cats (other than household pet kittens), must be registered with TICA before competing in their second show. Please contact TICA for registration information (TICA, P. O. Box 2684, Harlingen, TX 78551) or at www.tica.org.

Show Rules: TICA show rules will be strictly enforced. By entering, exhibitors agree to abide by the decisions of the judges and show committee. Official show rules can be obtained from TICA, P.O. Box 2684, Harlingen, TX 78551 or on www.tica.org.

Benching: One adult or two kittens are allowed per single cage space. A single cage (also noted in the pricing as an extra 1/2 cage) is approximately 22"L X 22"W X 22"H. Most entry fees include full double cages spaces (approximately 44"L x 22"W x 22"H). Anyone using their own cages/show tents must have full-double cage spaces. For those using club-provided wire cages, the two sides, back, and top must be covered. For the comfort of your cat(s), please bring something for the bottom of the cage too! Benching requests will be honored to the best of our ability.

Grooming spaces: These measure 44"L x 22"D and are on a waitlist-basis only depending on space availability when we close the show. The earlier you enter, the greater the possibility that you will be on the top of the list for a grooming space. If we can give you a grooming space, you can pay for it at check-in at the show.

Extra Double Cages/For Sale: Extra double cages and sales cages will be available to exhibitors and are on a waitlist-basis the same grooming spaces. TICA rules allow no more than two kittens or one cat 8 months of age or older benched in a single ½ cage space. No kitten under 3 months of age will be allowed in the show hall (be prepared to show proof of age), and no kittens or cats may be confined to carriers during show hours.

Services: Litter will be available. Please bring your own litter pans, cat food, and bowls.

Health: This is a non-vetted show. Cats showing signs of ear mites, fleas, fungus, or other illness will be escorted from the show hall along with any other cats owned, housed, or agented by the same exhibitor. All entries should be immunized against rabies, feline rhinotracheitis, calici virus, and panleukopenia, and should test negative for feline leukemia and feline AIDS. Any feline from a house or cattery where there has been fungus or any infectious or contagious illness within twenty-one days prior to the opening day of the show is ineligible for entry. An obviously pregnant or lactating cat will be disqualified. TICA show rules require all claws, front and back, be clipped prior to judging.

Kittens: All kittens entered for competition must be at least four (4) and not more than eight (8) calendar months old on the day of the show. Kittens may be spayed or neutered.

Household Pets: Household pets are very welcome at this show! Household pets 8 months of age and older MUST be spayed or neutered. If you are not sure of the proper class or color of your cat, check out <http://www.seregiontica.org/Colors/intro.htm> or send the entry clerk a color photo of your entry.

Clerks/Stewards: If you are interested in clerking, please indicate so on the summary sheet, along with any judge preference. TICA licensed clerks will be given preference and judge requests will be honored to the best of our ability. TICA certified clerks will be compensated \$40 per session plus a meal and a fully marked catalog. Stewards are also needed. Stewards will be paid \$25 per day. Please let us know on the summary sheet if you have someone available.

Awards: Awards will be awarded in accordance with TICA Show Rules. This show is scored for TICA Regional and International awards.

Sponsors: A show cannot survive without sponsors and do we have a deal for you! You can sponsor one judge in one ring for \$25. But, if you want to, you can sponsor ALL judges in ALL rings for the entire show for \$100!
